Optional One Page Tax Form

"One Page. One Rate. One Simple Choice"

- 1. All Income** (wages, tips, compensation from unemployment or retirement. Excludes interest, dividends, capital gains)
- 2. Personal exemptions**
 - (a) If married filing jointly, enter \$25,580
 - (b) If single head of household, enter \$16,330
 - (c) If single, enter \$12,790
 - (d) No. of dependents multiplied by \$5,510
- 3. Add lines 2a through 2d**
- 4. Taxable income** (line 1 minus line 3)
If negative, enter 0
- 5. Calculate tax** (multiply line 4 by 0.19)
- 6. Taxes already withheld**
- 7. Tax/Refund**
 - (a) If line 5 is greater than line 6, subtract line 6 from line 5. This is the AMOUNT YOU OWE
 - (b) If line 6 is greater than line 5, subtract line 5 from line 6. This is YOUR REFUND
