PROCLAMATION
BY THE
Governor of the State of Texas

TO ALL TO WHOM THESE PRESENTS SHALL COME:

I, RICK PERRY, Governor of Texas, do hereby certify that the severe storms, flash flooding, and flooding that began May 23, 2007, and continuing have caused a disaster in Archer, Baylor, Bell, Blanco, Brown, Burnet, Callahan, Coleman, Collin, Comanche, Eastland, Ellis, Fannin, Gillespie, Hamilton, Hood, Hunt, Jones, Lamar, Lipscomb, Llano, Mason, McLennan, Menard, Mills, Ochiltree, Parker, Runnels, San Saba, Starr, Stephens, Travis, Webb, Wichita, Williamson, Wise, and Young Counties, in the State of Texas.

These counties are in addition to the seven counties previously certified on my June 19, 2007 and June 22, 2007 proclamations. Those counties were Bosque, Cooke, Coryell, Denton, Grayson, Lampasas, and Tarrant.

THEREFORE, in accordance with the authority vested in me by Section 418.014 of the Texas Government Code, I do hereby proclaim the existence of such threat and direct that all necessary measures both public and private as authorized under Section 418.015 of the code be implemented to meet that threat.

As provided in section 418.016, all rules and regulations that may inhibit or prevent prompt response to this threat are suspended for the duration of the incident.

In accordance with the statutory requirements, copies of this proclamation shall be filed with the applicable authorities.
