
As the Center for Medicare and Medicaid Innovation (CMMI) continues to examine innovative payment and delivery models in the Medicare program, we ask you to consider a model that improves competition and empowers patients in their treatment decisions. As hospital consolidation is both occurring at a rapid pace and resulting in higher costs for both beneficiaries and the Medicare program, initiatives at physician-owned hospitals are important in maintaining quality and access to health care for American patients.

Physician-owned hospitals (POHs) receive some of the highest ratings in Medicare's quality programs, which have resulted in improved care and outcomes for beneficiaries. Additionally, these hospitals are among the top scorers in the Medicare Hospital Readmissions Reductions program, generating savings for the Medicare program. Unfortunately, patient access to these hospitals is hampered by section 6001 of the Affordable Care Act, which prohibits most grandfathered POHs from expanding to serve additional Medicare beneficiaries. Given the high quality of care furnished by POHs and the ongoing issues with hospital consolidation, we think it would be beneficial to launch a CMMI demonstration that aims to expand patient access to these quality providers. Such a demonstration would be consistent with your efforts to reward providers "that deliver coordinated, quality care, at the best value."

We encourage you to design a POH-led demonstration that fosters patient engagement, tailored educational efforts, and other strategies to improve care quality and achieve other critical outcomes, such as reduced inappropriate opioid use. This complements CMS' efforts to empower patients in their treatment decisions.

We appreciate your consideration of this important issue.


